5. Educational transcript from your highest degree attained. If your transcripts are not in English, please also provide a listing of all coursework with grade and credit hour information.
6. One reprint of your most significant research paper, including a description of your role in the research. If the paper is not in English, please provide an English translation.
7. Proof of proficiency in English for candidates whose native language is not English. Candidates who have completed a degree wholly in English can provide a copy of their degree as proof of proficiency. All other candidates should send a copy of their scores in an approved English Language Test.

The Institute of Health and Society seeks to appoint a Senior Research Associate, based in Newcastle upon Tyne, to coordinate research in four Mediterranean countries (Syria, Tunisia, Turkey and Palestine). This forms part of a new EU-FP7 project investigating cardiovascular diseases and diabetes, and the health policies aimed at reducing the burden of these diseases in those countries.

The work will involve particular responsibility for one work package: the comparative analysis of health policies, the organisation of the health sector, and the ways in which people access both formal and informal sources of medical treatment. You will direct and coordinate researchers in each participating country; some travel will be needed.

Applicants should have a relevant PhD plus post-doctoral research experience, or a relevant policy research background. We particularly encourage applications from medical anthropologists or geographers, or those with international health policy experience in developing countries. Knowledge of various research methodologies both qualitative and quantitative is essential, as is the ability to work with policy makers. Previous experience of epidemiological or health services research would be an advantage; some knowledge of cardiovascular disease and/or diabetes is desirable. **Sexual Health National Knowledge Week  
HIV/AIDs: behaviour change in high risk populations  
National Library for Public Health 1<sup>st</sup> to 7<sup>th</sup> December**

The National Library for Public Health presents its first Sexual Health National Knowledge Week (NKW) on **HIV/AIDs: behaviour change in high risk populations**. This has been timed to coincide

with [World HIV/AIDS Day](#) on the 1<sup>st</sup> of December. The NKW has been prepared in collaboration with the [British HIV Association](#). The NKW contains an annual evidence update on resources on the topic area and expert articles. It provides a one stop shop for those seeking the most up to date evidence and useful information on reducing the transmission of HIV and interventions for behaviour change in high risk populations.

The Wellcome Trust and the Alliance for Health Policy and Systems Research (HPSR) have launched a new initiative to promote the use of research evidence in developing health policy.

Now, the Wellcome Trust and the Alliance HPSR have joined together for a US\$1 million initiative aimed at ensuring that policymakers in low-income countries, such as politicians, civil servants, political advisors, and health system managers, have the necessary skills to apply research evidence in the policy process.

Examples of ways in which to enhance capacity to use evidence in policymaking include:

- Providing training and/or mentoring in how to acquire, assess, adapt and apply of research evidence;
- Internships that enable policymakers to spend time in research environments or vice versa;
- Improving access to research resources for policymakers through the launch of websites dedicated to evidence for policymaking;
- Establishing databases of local researchers and their interests which policymakers could draw upon when seeking evidence;
- Supporting legislation that requires publication of evidence base for new policies.
